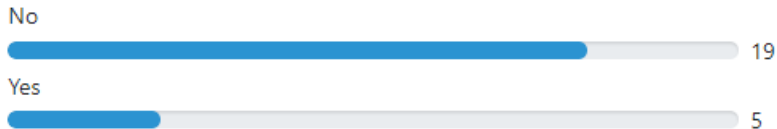

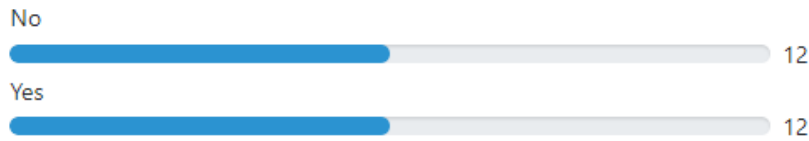

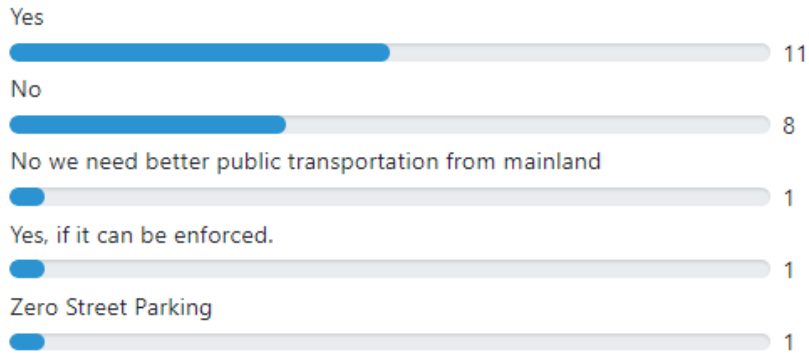

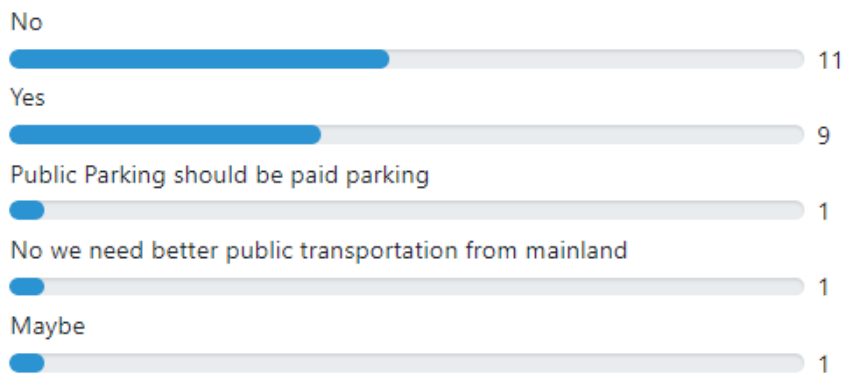

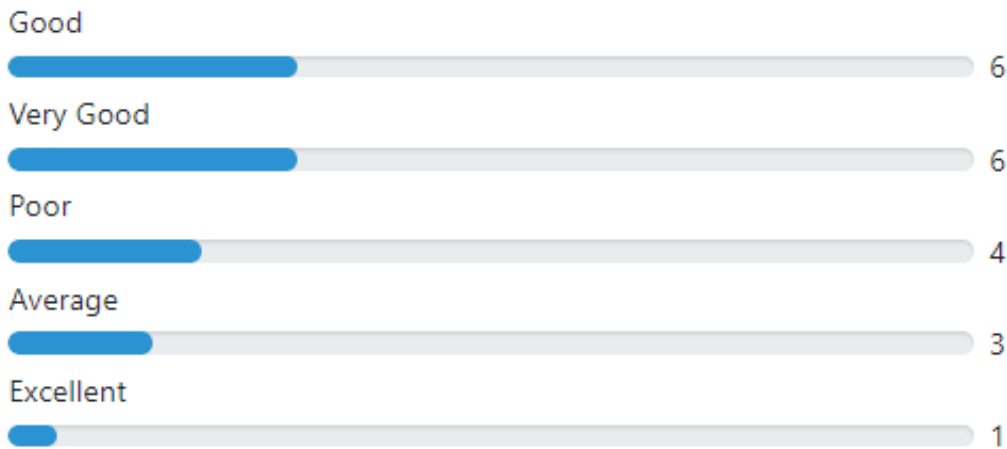

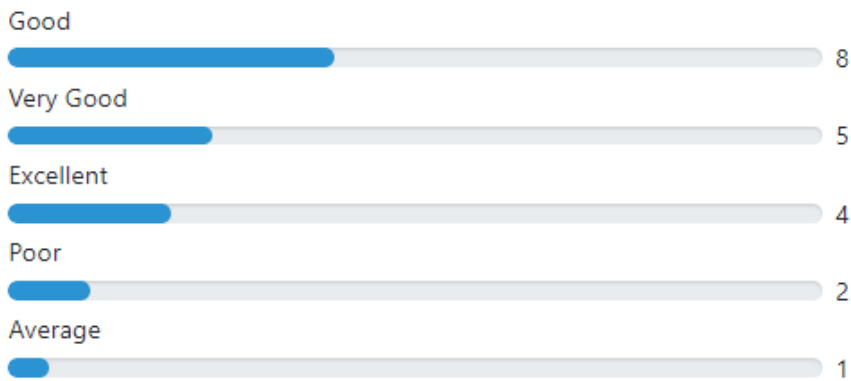
## How would you rank Commissioner Bender's performance as an elected official?

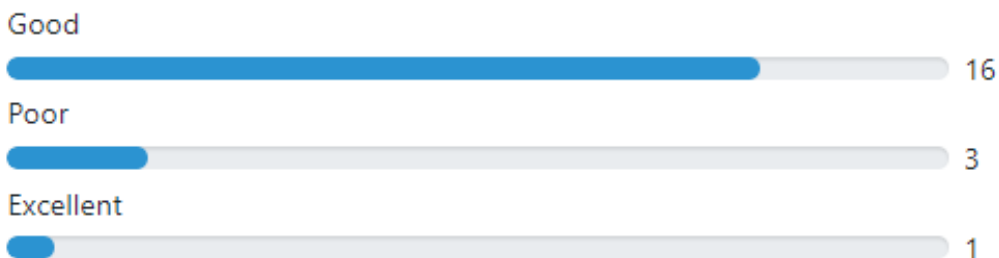
## How would you rank SRIA board member Tom Campanella's performance as an elected official?

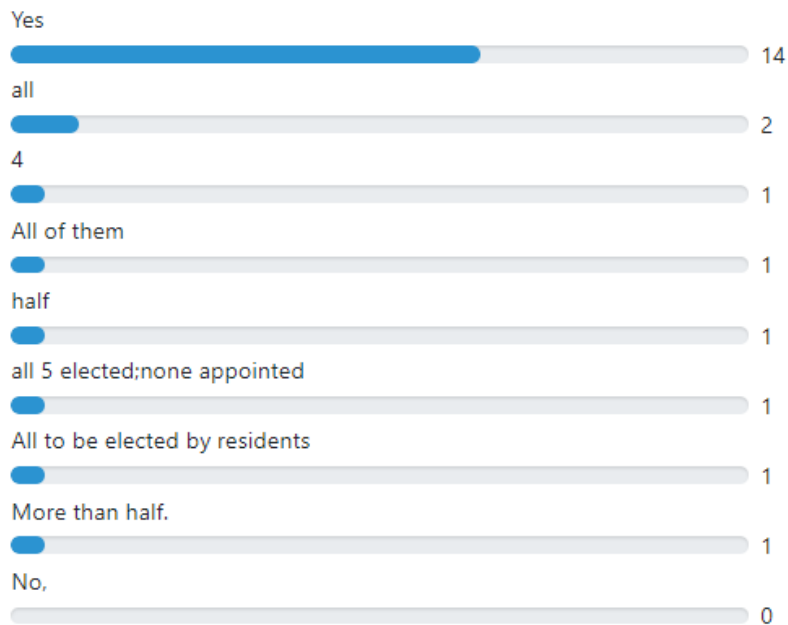

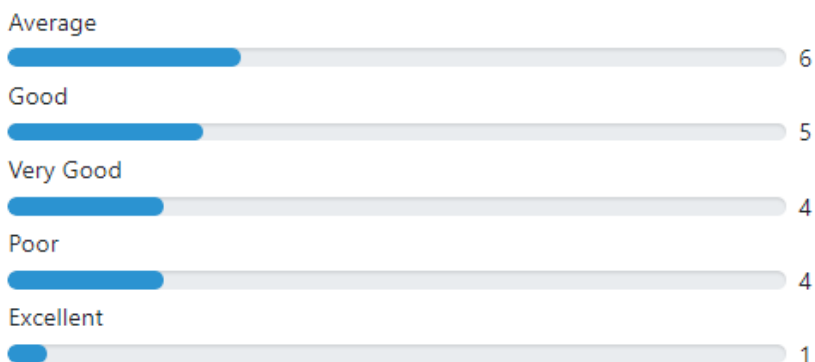

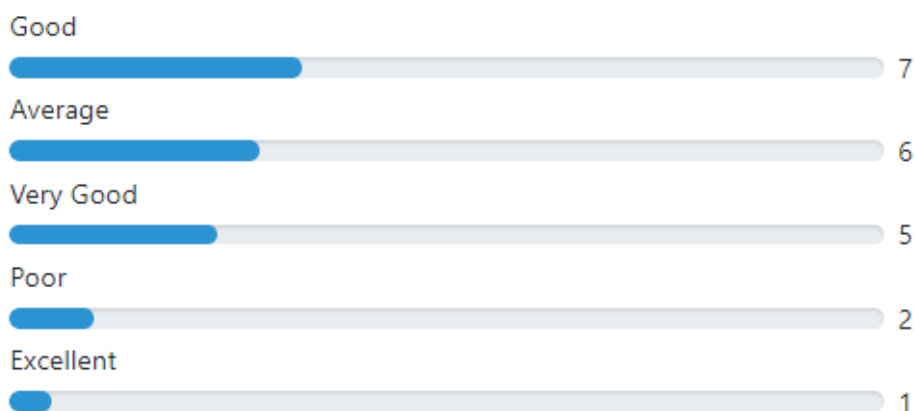
**How would you rank State Representative Alex Andrade's performance as a state legislator?**

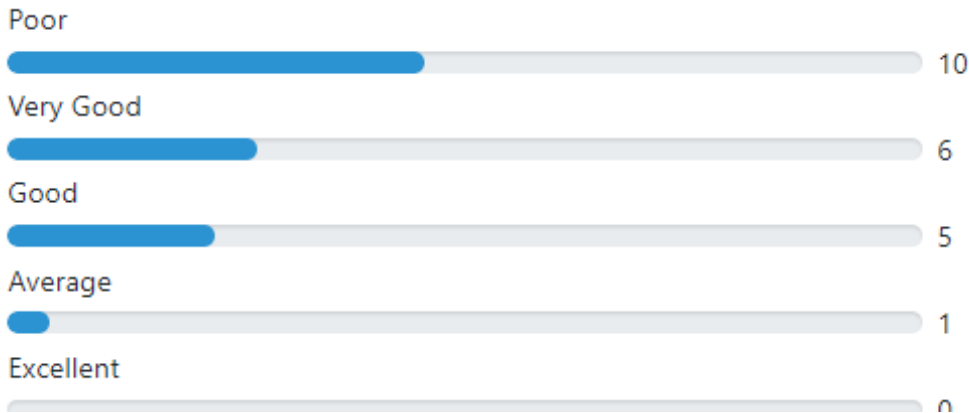

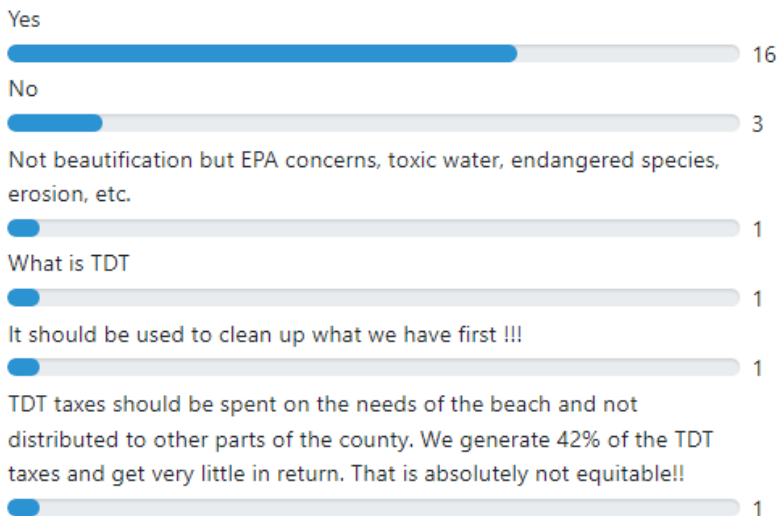
